



Suggested wording

If you are making your will and a resident of the UK you may find the following forms of wording useful when you consider leaving a gift to Arthur Rank Hospice Charity. We recommend that the wording is carefully reviewed by you and your solicitor in the context of your will. If you are not a UK resident, this language may provide a guide for you and your solicitor to talk about your will. You will need to rely on your solicitor for language that complies with the inheritance laws of your country.

Pecuniary Legacy

A pecuniary gift is for a specified sum of money. As inflation rises and living costs increase, monetary gifts are subject to lose value therefore you may wish to update the gift periodically or consult your solicitor on ways to protect the value of a gift like this.

Suggested wording

I give, free of inheritance tax, to Arthur Rank Hospice Charity the sum of such sum as shall be produced by multiplying £_____ by the index figure in the Retail Prices Index for the month immediately preceding my death and dividing the product by the index figure for the month in which my will is executed for:

1) the general purposes of Arthur Rank Hospice Charity

OR

2) the following purpose or department

The receipt of the person appearing to my Executors or Trustees to be the authorised officer of Arthur Rank Hospice Charity shall be a full discharge to my Executors or Trustees who shall not thereafter be concerned as to the application of this gift.

Residuary Legacy

A residuary gift is given as a percentage or share of your estate once all specific gifts, debts or expenses have been met.

Suggested wording:

I give to Arthur Rank Hospice Charity _____ per cent of my residuary estate for:

1) the general purposes of Arthur Rank Hospice Charity

OR

2) the following purpose or department

If at my death this area is fully funded, or if it is no longer an area which the Arthur Rank Hospice Charity is involved, I wish that my gift is used to support activities that are as close as possible to my original intentions at the discretion of Arthur Rank Hospice Charity.

The receipt of the person appearing to my Executors or Trustees to be the authorised officer of Arthur Rank Hospice Charity shall be a full discharge to my Executors or Trustees who shall not thereafter be concerned as to the application of this gift.

Specific (non-monetary) Legacy

This is a bequest of particular items or assets to the named beneficiary which are not in the form of money. This could be property, stocks and shares, works of art, or other valuable items.

Suggested wording

I give to Arthur Rank Hospice Charity my (full description of item and location). I direct that the receipt of the person appearing to my Executors or Trustees to be the authorised officer of Arthur Rank Hospice Charity shall be a full discharge to my Executors or Trustees who shall not thereafter be concerned as to the application of this gift.
