

## **Summer Super Draw 2025**

### **Terms and Conditions**

- This raffle is only open to residents of Great Britain over the age of 18 (this excludes Northern Ireland, Isle of Man, Channel Islands and BFPO addresses according to the Gambling Act 2005 regulations)
- No ticket can be sold to, on behalf of, or for a person under the age of 18.
- If a ticket is sold unknowingly to, on behalf of, or for a person under the age of 18 they will be exempt from the raffle and will forfeit their prize, and the stake will be returned.
- The cost of each entry is £1. Players may purchase more than one entry and payment must be in advance.
- All proceeds from this raffle will be used for the charitable purposes of Arthur Rank Hospice Charity.
- The prizes are: 1st prize £2,000, 2nd prize £500, 3rd prize £250, 5 x runners up prizes of £50. Prizes will be allocated in order of the tickets being drawn from the 1st prize down to the last one.

- It will not be possible to purchase online tickets after 23:59 on 31 July 2025.

- The charity accepts no responsibility for raffle ticket stubs which are damaged or illegible, or from which the prize-winner cannot be identified.
- Late entries will be treated as donations.
- All online raffle tickets purchased will be assigned a unique ticket number and added to paper ticket stubs for the draw.
- Refunds will only be issued at the discretion of Arthur Rank Hospice Charity and are not guaranteed.
- The draw will be held on 7 August 2025, drawn at 2pm from Arthur Rank Hospice Charity, Shelford Bottom, Cambridge.

- Winners will be notified by post, email or telephone no later than two weeks after the draw date. Please keep your ticket number or online purchase receipt as proof of purchase.
- A list of winning ticket numbers and surnames will also be published on the website within two weeks of the draw date.
- Winning participants names and general location may be used in promotional materials unless they request otherwise.
- Prizes will be in the form of cheques or bank transfer- each made payable to the winner as identified on the ticket stubs/online entry- and posted to the winners. Please allow up to two weeks after the raffle for receipt.
- If a prize is unclaimed after reasonable efforts have been made by Arthur Rank Hospice Charity to contact the winner, then Arthur Rank Hospice Charity will be entitled to dispose of the prize as it thinks fit. The winner has one month after notification to claim the prize.
- Arthur Rank Hospice Charity reserves the right to cancel the raffle in exceptional circumstances. In such case, refunds will be issued upon request.
